Summary (as of Mar 15, 2017)

Helping Ensure Life- and Limb-Saving Access to Podiatric Physicians Act or the HELLPP Act

This bill adds podiatrists as covered physicians under the Medicaid program.

Documentation requirements related to Medicare coverage of therapeutic shoes for individuals with diabetes are revised.

The bill amends the Internal Revenue Code to subject payments made to a Medicaid provider or supplier to a continuing levy for federal taxes owed by the provider or supplier.

Actions Timeline

- **Mar 24, 2017:** Referred to the Subcommittee on Health.
- **Mar 17, 2017:** Referred to the Subcommittee on Health.
- **Mar 15, 2017:** Introduced in House
- **Mar 15, 2017:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
