## Summary (as of Mar 16, 2017)

### Donald Payne Sr. Colorectal Cancer Detection Act of 2017

This bill amends title XVIII (Medicare) of the Social Security Act to provide for Medicare coverage and payment, subject to specified frequency limits, of certain colorectal cancer screening blood-based tests.

- **Mar 24, 2017:** Referred to the Subcommittee on Health.
- **Mar 17, 2017:** Referred to the Subcommittee on Health.
- **Mar 16, 2017:** Introduced in House
- **Mar 16, 2017:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
