Wounded Veterans Recreation Act

This bill amends the Federal Lands Recreation Enhancement Act to require the National Parks and Federal Recreational Lands Pass, which is made available for the lifetime of the passholder without charge to any U.S. citizen or person domiciled in the United States who has been medically determined to be permanently disabled, to be made available to any veteran with a service-connected disability.

Actions Timeline

- **Apr 11, 2017:** Referred to the Subcommittee on Conservation and Forestry.
- **Mar 27, 2017:** Referred to the Subcommittee on Federal Lands.
- **Mar 17, 2017:** Introduced in House
- **Mar 17, 2017:** Referred to the Committee on Natural Resources, and in addition to the Committee on Agriculture, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
