Provides FY2018 appropriations to the Department of Transportation (DOT), the Department of Housing and Urban Development (HUD), and several related agencies.

### *Department of Transportation Appropriations Act, 2018*

Provides appropriations to DOT for:

- the Office of the Secretary,
- the Federal Aviation Administration,
- the Federal Highway Administration,
- the Federal Motor Carrier Safety Administration,
- the National Highway Traffic Safety Administration,
- the Federal Railroad Administration,
- the Federal Transit Administration,
- the Saint Lawrence Seaway Development Corporation,
- the Maritime Administration,
- the Pipeline and Hazardous Materials Safety Administration, and
- the Office of Inspector General.

### *Department of Housing and Urban Development Appropriations Act, 2018*

Provides appropriations to HUD for:

- Management and Administration,
- Program Office Salaries and Expenses,
- Public and Indian Housing,
- Community Planning and Development,
- Housing Programs,
- the Federal Housing Administration,
- the Government National Mortgage Association (Ginnie Mae),
- Policy Development and Research,
- Fair Housing and Equal Opportunity,
- the Office of Lead Hazard Control and Healthy Homes,
- the Information Technology Fund, and
- the Office of Inspector General.

Provides appropriations to related agencies, including:

- the Access Board,
- the Federal Maritime Commission,
- the National Railroad Passenger Corporation (Amtrak) Office of Inspector General,
- the National Transportation Safety Board,
- the Neighborhood Reinvestment Corporation,

the Surface Transportation Board, and

- the U.S. Interagency Council on Homelessness.

Rescinds specified unobligated balances from prior appropriations. Sets forth permissible and prohibited uses for funds provided by this and other appropriations Acts.
