## **Donate for Disaster Relief Act of 2017**

This bill amends the Internal Revenue Code to allow individual taxpayers to designate an amount (not less than \$1) of any overpayment of income tax to a Disaster Relief Fund, established by this bill, for the purpose of providing relief for major disasters declared under the Robert T. Stafford Disaster Relief and Emergency Assistance Act.

## **Actions Timeline**

- **Jan 4, 2017:** Referred to the Subcommittee on Economic Development, Public Buildings and Emergency Management.
- **Jan 3, 2017:** Introduced in House
- **Jan 3, 2017:** Referred to the Committee on Ways and Means, and in addition to the Committee on Transportation and Infrastructure, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
