## Summary (as of Mar 24, 2017)

### ObamaCare Repeal Act

This bill repeals the Patient Protection and Affordable Care Act and the Health Care and Education Reconciliation Act of 2010, effective as of December 31, 2017. Provisions of law amended by those Acts are restored.

### Actions Timeline

- **Mar 31, 2017:** Referred to the Subcommittee on Health.
- **Mar 30, 2017:** Referred to the Subcommittee on Indian, Insular and Alaska Native Affairs.
- **Mar 24, 2017:** Introduced in House
- **Mar 24, 2017:** Referred to the Committee on Energy and Commerce, and in addition to the Committees on Ways and Means, Education and the Workforce, Natural Resources, the Judiciary, House Administration, Rules, and Appropriations, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
