## Summary (as of Apr 6, 2017)

### Opioid Preventing Abuse through Continuing Education Act of 2017 or the Opioid PACE Act of 2017

This bill amends the Controlled Substances Act to require a practitioner (other than a hospital, pharmacy, pharmacist, or veterinarian) to comply with a training requirement, as a condition of obtaining or renewing a registration to prescribe or dispense opioids for the treatment of pain or pain management.

## Actions Timeline

- **May 1, 2017:** Referred to the Subcommittee on Crime, Terrorism, Homeland Security, and Investigations.
- **Apr 7, 2017:** Referred to the Subcommittee on Health.
- **Apr 6, 2017:** Introduced in House
- **Apr 6, 2017:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on the Judiciary, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
