Summary (as of Mar 20, 2017)

Sets forth the rule for consideration of the bill (H.R. 1101) to amend title I of the Employee Retirement Income Security Act of 1974 to improve access and choice for entrepreneurs with small businesses with respect to medical care for their employees.

Actions Timeline

- **Mar 21, 2017:** DEBATE - The House proceeded with one hour of debate on H. Res. 210.
- **Mar 21, 2017:** POSTPONED PROCEEDINGS - At the conclusion of debate on H.Res. 210, the Chair put the question on ordering the previous question and by voice vote, announced that the ayes had prevailed. Mr. Polis demanded the yeas and nays and the Chair postponed further proceedings on the previous question until a time to be announced.

- **Mar 21, 2017:** On ordering the previous question Agreed to by the Yeas and Nays: 233 - 186 (Roll no. 179). (consideration: CR H2260-2267, H2275)
- **Mar 21, 2017:** Passed/agreed to in House: On agreeing to the resolution Agreed to by recorded vote: 233 - 186 (Roll no. 180).(text of measure as passed: CR H2260)
- **Mar 21, 2017:** On agreeing to the resolution Agreed to by recorded vote: 233 - 186 (Roll no. 180). (text of measure as passed: CR H2260)
- **Mar 21, 2017:** Motion to reconsider laid on the table Agreed to without objection.
- **Mar 20, 2017:** Introduced in House
- **Mar 20, 2017:** The House Committee on Rules reported an original measure, H. Rept. 115-51, by Mr. Byrne.
- **Mar 20, 2017:** Rule provides for consideration of H.R. 1101 with 1 hour of general debate. Previous question shall be considered as ordered without intervening motions except motion to recommit with or without instructions. Measure will be considered read. Specified amendments are in order.
- **Mar 20, 2017:** Placed on the House Calendar, Calendar No. 23.
