- **Jan 5, 2017:** On agreeing to the resolution Agreed to by recorded vote: 231 - 187 (Roll no. 10). (text: CR H113)
- **Jan 5, 2017:** Motion to reconsider laid on the table Agreed to without objection.
- **Jan 4, 2017:** Introduced in House
- **Jan 4, 2017:** The House Committee on Rules reported an original measure, H. Rept. 115-1, by Mr. Collins (GA).
- **Jan 4, 2017:** Both measures shall be considered as read, the previous questions shall be considered as ordered without intervening motion or demand for division of the question except one hour of debate. The rule makes in order a motion to recommit H.R. 26 with or without instructions.
