Summary (as of May 2, 2017)

Bureau of Land Management Headquarters Relocation Act

This bill directs the Department of the Interior to submit a strategy, including a proposed time line, for relocating the headquarters of the Bureau of Land Management (BLM) from Washington, DC, to Alaska, Arizona, California, Colorado, Idaho, Montana, Nevada, New Mexico, Oregon, Utah, Washington, or Wyoming in a manner that will save the maximum amount of taxpayer money practicable.

The bill authorizes such relocation.

Actions Timeline

- **May 11, 2017:** Referred to the Subcommittee on Federal Lands.
- **May 2, 2017:** Introduced in House
- **May 2, 2017:** Referred to the House Committee on Natural Resources.
