- **Mar 28, 2017:** DEBATE - The House proceeded with one hour of debate on H. Res. 229.
- **Mar 28, 2017:** POSTPONED PROCEEDINGS - At conclusion of debate on H.Res. 229, the Chair put the question on ordering the previous question on H.Res. 229 and by voice vote, announced that the ayes had prevailed. Mr. Polis demanded the yeas and nays and the Chair postponed further proceedings on ordering the previous question until a time to be announced.
- **Mar 28, 2017:** Considered as unfinished business. (consideration: CR H2486-2487)
- **Mar 28, 2017:** On ordering the previous question Agreed to by the Yeas and Nays: 231 - 189 (Roll no. 197). (consideration: CR H2486-2487)
- **Mar 28, 2017:** Passed/agreed to in House: On agreeing to the resolution Agreed to by recorded vote: 231 - 185 (Roll no. 198).(text: CR H2471)
- **Mar 28, 2017:** On agreeing to the resolution Agreed to by recorded vote: 231 - 185 (Roll no. 198). (text: CR H2471)
- **Mar 28, 2017:** Motion to reconsider laid on the table Agreed to without objection.
- **Mar 27, 2017:** Introduced in House
- **Mar 27, 2017:** The House Committee on Rules reported an original measure, H. Rept. 115-60, by Mr. Woodall.
- **Mar 27, 2017:** Rule provides for consideration of H.R. 1430 with 1 hour of general debate. Previous question shall be considered as ordered without intervening motions except motion to recommit with or without instructions. Measure will be considered read. Bill is closed to amendments.
- **Mar 27, 2017:** Placed on the House Calendar, Calendar No. 27.
