Summary (as of Jan 3, 2017)

Safe Freight Act of 2017

This bill prohibits the operation of a freight train or light locomotive engine used in the movement of freight unless it has a crew of at least two individuals, one of whom is certified by the Federal Railroad Administration as a locomotive operator and the other as a train conductor.

Actions Timeline

- **Jan 4, 2017:** Referred to the Subcommittee on Railroads, Pipelines, and Hazardous Materials.
- **Jan 3, 2017:** Introduced in House
- **Jan 3, 2017:** Referred to the House Committee on Transportation and Infrastructure.
