(This measure has not been amended since it was introduced. The summary of that version is repeated here.)

Directs the Department of Homeland Security (DHS) to transmit to the House of Representatives copies of any document, correspondence, or other communication of DHS that refers or relates to:

- DHS research, integration, and analysis activities relating to interference with the 2016 elections by or at the direction of the Russian government, as announced in a joint statement with the Office of the Director of National Intelligence on October 7 and December 29, 2016;
- dissemination by DHS of information regarding such interference, as announced in such statement;
- research into cyber compromises of email of U.S. persons and institutions by or at the direction of the Russian government to interfere with such elections; and
- integration, analysis, and dissemination of the Joint Analysis Report detailing the tools and infrastructure used by Russian intelligence services to compromise and exploit networks and infrastructure associated with such elections issued by DHS and the Federal Bureau of Investigation on December 29, 2016.
