Summary (as of May 16, 2017)

Justice Safety Valve Act of 2017

This bill amends the federal criminal code to authorize a court to impose a sentence below the mandatory minimum if it determines, after considering certain factors, that the mandatory minimum sentence is greater than necessary.

- May 16, 2017: Referred to the House Committee on the Judiciary.
