Summary (as of Sep 12, 2017)

Federal Information Resource to Strengthen Ties with State and Local Law Enforcement Act of 2017 or the FIRST State and Local Law Enforcement Act

(Sec. 2) This bill amends the Homeland Security Act of 2002 to require the Department of Homeland Security's Office for State and Local Law Enforcement to report annually on its activities.

Actions Timeline

- **Sep 13, 2017:** Received in the Senate and Read twice and referred to the Committee on Homeland Security and Governmental Affairs.
- **Sep 12, 2017:** Mr. Hurd moved to suspend the rules and pass the bill, as amended.

- **Sep 12, 2017:** DEBATE - The House proceeded with forty minutes of debate on H.R. 2442.
- **Sep 12, 2017:** Passed/agreed to in House: On motion to suspend the rules and pass the bill, as amended Agreed to by voice vote.(text: CR H7245)
- **Sep 12, 2017:** On motion to suspend the rules and pass the bill, as amended Agreed to by voice vote. (text: CR H7245)
