Summary (as of May 22, 2017)

Medical Nutrition Equity Act of 2017

This bill provides for coverage, under Medicare, Medicaid, other specified federal health-care programs, and private health insurance, of foods and vitamins that are medically necessary for the management of certain digestive and metabolic disorders and conditions.

Actions Timeline

- **Jun 16, 2017:** Referred to the Subcommittee on Military Personnel.
- **Jun 5, 2017:** Referred to the Subcommittee on Health.
- **May 26, 2017:** Referred to the Subcommittee on Health.
- **May 22, 2017:** Introduced in House
- **May 22, 2017:** Referred to the Committee on Energy and Commerce, and in addition to the Committees on Ways and Means, Armed Services, and Oversight and Government Reform, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
