Chronic Kidney Disease Improvement in Research and Treatment Act of 2017

This bill modifies provisions relating to coverage for and access to treatment for chronic kidney disease, including Medicare payment provisions for renal dialysis services.

- **May 24, 2017:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
