### Martin Luther King, Jr. National Historical Park Act of 2017

(Sec. 2) This bill redesignates the Martin Luther King, Junior, National Historic Site in the state of Georgia as the "Martin Luther King, Jr. National Historical Park." The bill replaces the current boundary map with a map of a proposed boundary revision dated June 2015.

- **Mar 21, 2017:** Received in the Senate and Read twice and referred to the Committee on Energy and Natural Resources.
- **Mar 15, 2017:** Mr. Tipton moved to suspend the rules and pass the bill, as amended.
- **Mar 15, 2017:** Considered under suspension of the rules. (consideration: CR H2065-2066)
- **Mar 15, 2017:** DEBATE - The House proceeded with forty minutes of debate on H.R. 267.
- **Mar 15, 2017:** At the conclusion of debate, the chair put the question on the motion to suspend the rules. Mr. Tipton objected to the vote on the grounds that a quorum was not present. Further proceedings on the motion were postponed. The point of no quorum was considered as withdrawn.
