Volunteer Income Tax Assistance Permanence Act of 2017

This bill directs the Internal Revenue Service (IRS) to establish a Community Volunteer Income Tax Assistance Matching Grant Program to provide matching funds for the development, expansion, or continuation of tax preparation programs to assist low-income taxpayers and members of underserved populations.

Unless otherwise provided by a specific appropriation, the IRS may not allocate more than \$30 million per fiscal year (exclusive of costs of administering the program) for the program.
