## Summary (as of Jun 21, 2017)

This bill directs the United States Postal Service to issue and sell an Alzheimer's Disease Research Semipostal Stamp.

Proceeds from the sale of the stamp must be transferred to the National Institutes of Health.

The stamp must be made available to the public for six years.

## Actions Timeline

- **Jun 23, 2017:** Referred to the Subcommittee on Health.
- **Jun 21, 2017:** Introduced in House
- **Jun 21, 2017:** Referred to the Committee on Oversight and Government Reform, and in addition to the Committee on Energy and Commerce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
