Summary (as of Jun 23, 2017)

Mental Health Access Improvement Act of 2017

This bill amends title XVIII (Medicare) of the Social Security Act to: (1) cover marriage and family therapist services and mental health counselor services under Medicare, (2) exclude such services from the skilled nursing facility prospective payment system, and (3) authorize marriage and family therapists and mental health counselors to develop discharge plans for post-hospital services.

Actions Timeline

- **Jul 5, 2017:** Referred to the Subcommittee on Health.
- **Jun 30, 2017:** Referred to the Subcommittee on Health.
- **Jun 23, 2017:** Introduced in House
- **Jun 23, 2017:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
