Summary (as of Jun 25, 2018)

Helping to End Addiction and Lessen Substance Use Disorders Act of 2018 or the HEAL Act of 2018

This bill establishes a series of requirements under Medicare and Medicaid relating to substance-use disorder prevention and treatment, including educational programs, screening requirements, and prescription drug monitoring.
