## Summary (as of Jun 29, 2017)

### Preventing Diabetes in Medicare Act of 2017

This bill amends title XVIII (Medicare) of the Social Security Act to extend Medicare coverage for medical nutrition therapy services to beneficiaries with pre-diabetes or risk factors for developing type-2 diabetes.

## Actions Timeline

- **Jul 17, 2017:** Referred to the Subcommittee on Health.
- **Jun 30, 2017:** Referred to the Subcommittee on Health.
- **Jun 29, 2017:** Introduced in House
- **Jun 29, 2017:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
