A bill to amend title XVIII of the Social Security Act to improve access to, and utilization of, bone mass measurement benefits under part B of the Medicare program by establishing a minimum payment amount under such part for bone mass measurement.

115 HR 1898	Related bill	<b>Jul 11, 2018:</b> ASSUMING FIRST SPONSORSHIP - Mrs. Blackburn asked unanimous consent that she may hereafter be the first sponsor of H.R. 1898, a bill originally introduced by Representative Meehan, for the purpose of adding cosponsors and requesting reprintings pursuant to clause 7 of rule XII. Agreed to without objection.

This bill specifies that certain Medicare payment rules applicable to imaging services shall apply to dual-energy x-ray absorptiometry services used in bone mass scans beginning in 2019.

The Centers for Medicare & Medicaid Services must establish national minimum payment amounts for such services.
