- **May 18, 2017:** Passed/agreed to in House: On agreeing to the resolution Agreed to by recorded vote: 230 - 184 (Roll no. 264). (text: CR H4325)

- **May 18, 2017:** Motion to reconsider laid on the table Agreed to without objection.
- **May 16, 2017:** Introduced in House
- **May 16, 2017:** The House Committee on Rules reported an original measure, H. Rept. 115-127, by Mr. Collins (GA).
- **May 16, 2017:** Rule provides for consideration of the bill under a structured rule with one hour of general debate equally divided between the chair and ranking member of the Committee on the Judiciary. The resolution also provides for one motion to recommit with or without instructions.
- **May 16, 2017:** Placed on the House Calendar, Calendar No. 50.
