Summary (as of Jul 19, 2017)

First Responder Fair Return for Employees on Their Initial Retirement Earned Act of 2017 or the First Responder Fair RETIRE Act

This bill preserves special federal retirement benefits for certain law enforcement officers, firefighters, air traffic controllers, nuclear materials couriers, and diplomatic special security agents who cannot meet the minimum age and service requirements for special retirement benefits due to a work-related injury or illness.

Actions Timeline

- **Mar 15, 2018:** Committee Consideration and Mark-up Session Held.
- **Mar 15, 2018:** Ordered to be Reported (Amended) by Voice Vote.
- **Jul 19, 2017:** Introduced in House
- **Jul 19, 2017:** Referred to the Committee on Oversight and Government Reform, and in addition to the Committees on Intelligence (Permanent Select), and Foreign Affairs, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
