States' Medical Marijuana Property Rights Protection Act

This bill amends the Controlled Substances Act to exempt real property from civil forfeiture due to medical marijuana-related conduct that is authorized by state law.

Actions Timeline

- **Jan 31, 2017:** Referred to the Subcommittee on Crime, Terrorism, Homeland Security, and Investigations.
- **Jan 25, 2017:** Referred to the Subcommittee on Health.
- **Jan 5, 2017:** Introduced in House
- **Jan 5, 2017:** Referred to the Committee on the Judiciary, and in addition to the Committee on Energy and Commerce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
