Ensuring Access to Air Ambulance Services Act of 2017

This bill makes a series of changes relating to payment of air ambulance services under Medicare, including by establishing certain cost-reporting requirements for providers.

Actions Timeline

- **Jul 28, 2017:** Referred to the Subcommittee on Health.
- **Jul 25, 2017:** Introduced in House
- **Jul 25, 2017:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
