## **Farewell to Unnecessary Energy Lifelines Reform Act of 2017 or the FUEL Reform Act**

This bill repeals title IX (Energy) of the Farm Security and Rural Investment Act of 2002, which authorized various energy programs that are administered by the Department of Agriculture and primarily provide support and incentives for renewable energy projects.

### **Actions Timeline**

- **May 22, 2018:** Referred to the Subcommittee on Energy.
- **Sep 1, 2017:** Referred to the Subcommittee on Commodity Exchanges, Energy, and Credit.
- **Jul 26, 2017:** Introduced in House
- **Jul 26, 2017:** Referred to the Committee on Agriculture, and in addition to the Committees on Oversight and Government Reform, and Science, Space, and Technology, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
