### Summary (as of Jul 27, 2017)

#### Office of Government Ethics Independence Act of 2017

This bill amends the Ethics in Government Act of 1978 to specify that the Director of the Office of Government Ethics may be removed only pursuant to a finding by the President of neglect of duty or malfeasance in office.

### Actions Timeline

- **Sep 6, 2017:** Referred to the Subcommittee on the Constitution and Civil Justice.
- **Jul 27, 2017:** Introduced in House
- **Jul 27, 2017:** Referred to the Committee on Oversight and Government Reform, and in addition to the Committee on the Judiciary, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
