Recognizing the Environmental Gains In Overcoming Negligence Act or the REGION Act

This bill prohibits funds made available for any fiscal year from being used to close, consolidate, or eliminate an office of the Environmental Protection Agency, including a regional or program office.

- **Jul 28, 2017:** Referred to the Committee on Energy and Commerce, and in addition to the Committees on Agriculture, Transportation and Infrastructure, and Science, Space, and Technology, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
