## Summary (as of Dec 4, 2018)

### NFIP Extension Act of 2018

This bill amends the National Flood Insurance Act of 1968 to reauthorize the National Flood Insurance Program through September 30, 2019.

The bill shall take effect as if it had been enacted on December 7, 2018.
