Summary (as of Sep 14, 2017)

High School Football Safety Study Act

This bill directs the Centers for Disease Control and Prevention to: (1) conduct a study to more precisely identify the causes of deaths related to high school football, (2) develop recommendations to prevent such deaths, and (3) submit to Congress and publish on the public website of the Agency for Healthcare Research and Quality a report on the study's results.

Actions Timeline

- **Sep 15, 2017:** Referred to the Subcommittee on Health.
- **Sep 14, 2017:** Introduced in House
- **Sep 14, 2017:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Education and the Workforce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
