## Summary (as of Jan 10, 2017)

Recognizes that it is no longer necessary for all federal agencies to be located in the District of Columbia.

Determines that executive agencies and military departments should be relocated outside the District of Columbia.

Calls on each executive agency and military department to recommend appropriate alternate locations throughout the United States to which they can be relocated.

- **Mar 10, 2017:** Ordered to be Reported (Amended) by the Yeas and Nays: 21 - 19.
- **Feb 21, 2017:** Referred to the Subcommittee on Readiness.
- **Jan 10, 2017:** Introduced in House
- **Jan 10, 2017:** Referred to the Committee on Oversight and Government Reform, and in addition to the Committee on Armed Services, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
