Summary (as of Sep 25, 2017)

Protecting Workers and Improving Labor Standards Act

This bill amends the National Labor Relations Act to allow labor agreements to require membership in a labor organization as a condition of employment regardless of state law (thus preempting state laws that prohibit such agreements).
