115 HR 256	Identical bill	<b>Apr 25, 2018:</b> ASSUMING FIRST SPONSORSHIP - Mr. Hunter asked unanimous consent that he may hereafter be considered as the first sponsor of H.R. 256, a bill originally introduced by former Representative Farenthold, for purposes of adding cosponsors and requesting reprintings pursuant to clause 7 of rule XII. Agreed to without objection.

#### **Protect Our Military Families' 2nd Amendment Rights Act**

This bill amends the federal criminal code to allow a licensed gun dealer, importer, or manufacturer to sell or ship a firearm to the spouse of a member of the U.S. Armed Forces on active duty. (Current law already allows a licensed dealer, importer, or manufacturer to sell a firearm to a member of the U.S. Armed Forces on active duty.)

The bill also specifies that, for purposes of federal firearms laws, a member of the U.S. Armed Forces on active duty, or his or her spouse, is a resident of the state in which: (1) the member or spouse maintains legal residence, (2) the permanent duty station of the member is located, and (3) the member maintains a home from which he or she commutes to the permanent duty station.
