A resolution calling upon the President to exercise relevant mandatory sanctions authorities under the Countering America's Adversaries Through Sanctions Act in response to the Government of the Russian Federation's continued aggression in Ukraine and illegal occupation of Crimea and assault on democratic institutions around the world, including through cyber attacks.

115 HRES 749	Identical bill	Feb 26, 2018: Referred to the Committee on Foreign Affairs, and in addition to the Committees on House Administration, the Judiciary, Oversight and Government Reform, Financial Services, and Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.

Calls for: (1) the President, the Department of the Treasury, and the Department of State to impose sanctions with respect to activities of the Russian Federation undermining cybersecurity, corruption in the Russian Federation, or other sanctionable conduct; and (2) the President to work with Congress to protect U.S. democratic institutions in advance of the 2018 elections.
