Denying Firearms and Explosives to Dangerous Terrorists Act of 2017

This bill authorizes the Department of Justice to deny the transfer of firearms or the issuance of firearms (and explosives) licenses and permits to a known or suspected terrorist.

Actions Timeline

- **Nov 1, 2017:** Referred to the Subcommittee on Crime, Terrorism, Homeland Security, and Investigations.

- **Oct 12, 2017:** Referred to the House Committee on the Judiciary.
