Summary (as of Oct 19, 2017)

Protect Access to Birth Control Act

This bill nullifies interim final rules issued by the Department of Labor, the Department of the Treasury, and the Department of Health and Human Services that allow employers with religious or moral objections to be exempt from the requirement in the Patient Protection and Affordable Care Act to cover contraceptive services without cost-sharing.

Actions Timeline

- **Oct 20, 2017:** Referred to the Subcommittee on Health.
- **Oct 19, 2017:** Introduced in House
- **Oct 19, 2017:** Referred to the Committee on Energy and Commerce, and in addition to the Committees on Ways and Means, and Education and the Workforce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
