This bill provides for Medicare coverage and payment of methadone (a medication used to treat opioid-use disorder).

- **Oct 23, 2017:** Introduced in House
- **Oct 23, 2017:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
