Summary (as of Nov 30, 2017)

Adoption Information Act

This bill amends the Public Health Service Act to require family planning service projects or programs, as a condition of receiving certain grants or contracts, to assure the Department of Health and Human Services (HHS) that they will provide each person who inquires about their services with a pamphlet containing a comprehensive list of adoption centers in their state.

The bill directs HHS to prepare, annually update, and distribute such pamphlets to such projects or programs.

Actions Timeline

- **Dec 1, 2017:** Referred to the Subcommittee on Health.
- **Nov 30, 2017:** Introduced in House
- **Nov 30, 2017:** Referred to the House Committee on Energy and Commerce.
