Sets forth the rule for consideration of the bill (H.R. 806) to facilitate efficient State implementation of ground-level ozone standards.

Actions Timeline

- **Jul 18, 2017:** Considered as privileged matter. (consideration: CR H5927-5935)
- **Jul 18, 2017:** DEBATE - The House proceeded with one hour of debate on H. Res. 451.
- **Jul 18, 2017:** POSTPONED PROCEEDINGS - At the conclusion of debate on H. Res. 451, the Chair put the question on ordering the previous question, and by voice vote announced that the ayes prevailed. Mr. Polis demanded the yeas and nays and the Chair postponed further proceedings on the question of ordering the previous question until later in the legislative day.
