This bill makes a series of changes relating to health insurance coverage and costs. Among other things, the bill establishes a specific fund to support state initiatives that reduce costs and terminates the medical device excise tax.

- **Dec 22, 2017:** Referred to the Subcommittee on Health.
- **Dec 20, 2017:** Introduced in House
- **Dec 20, 2017:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
