Summary (as of Jan 18, 2018)

Iran Freedom Policy and Sanctions Act

This bill sets forth requirements concerning the imposition of sanctions against entities owned or controlled by the Armed Forces of Iran, the reinstatement of certain sanctions that were suspended pursuant to the Joint Comprehensive Plan of Action, and the expansion or extension of sanctions with respect to Iran's ballistic missile program.

Actions Timeline

- **Jan 23, 2018:** Referred to the Subcommittee on Trade.
- **Jan 18, 2018:** Introduced in House
- **Jan 18, 2018:** Referred to the Committee on Foreign Affairs, and in addition to the Committees on Financial Services, the Judiciary, Oversight and Government Reform, and Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
