Medgar Evers National Monument Act

This bill establishes the Medgar Evers National Monument in Jackson, Mississippi, as a unit of the National Park System to preserve, protect, and interpret the home and history of the pivotal role of Medgar Evers in the civil rights movement.

The National Park Service shall enter into a cooperative agreement with Tougaloo College in Tougaloo, Mississippi, for interpretive and educational programming related to the monument.
