This bill directs the Department of the Interior to conduct a special resource study to determine the suitability and feasibility of establishing the birthplace of James Weldon Johnson located at Adams and Lee Streets in Jacksonville, Florida, as a unit of the National Park System. James Weldon Johnson was a renowned statesmen, educator, songwriter, author, lawyer, and civil rights activist.
