This bill requires hospitals, as a condition of Medicare participation, to develop staffing plans for nursing services in accordance with specified criteria.

- **Feb 15, 2018:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
