Summary (as of Feb 27, 2018)

Recovery Home Certification Act of 2018

This bill requires the Center for Substance Abuse Treatment and Recovery to establish model criteria for recovery homes and award grants to states that establish and operate recovery homes based on such model criteria.

The bill also makes it unlawful to make or receive payments for referrals to recovery homes or clinical treatment facilities.

Actions Timeline

- **Mar 20, 2018:** Referred to the Subcommittee on Crime, Terrorism, Homeland Security, and Investigations.
- **Mar 2, 2018:** Referred to the Subcommittee on Health.
- **Feb 27, 2018:** Introduced in House
- **Feb 27, 2018:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on the Judiciary, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
