This bill provides support for water recycling and reuse projects, including support for the Bureau of Reclamation's grant program for water recycling.

This bill reauthorizes and revises the Environmental Protection Agency's grant program for alternative water sources and water recycling.

- **Mar 6, 2018:** Referred to the Subcommittee on Water, Power and Oceans.
- **Feb 28, 2018:** Referred to the Subcommittee on Water Resources and Environment.
- **Feb 27, 2018:** Introduced in House
- **Feb 27, 2018:** Referred to the Committee on Natural Resources, and in addition to the Committee on Transportation and Infrastructure, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
