Undo Sabotage and Expand Affordability of Health Insurance Act of 2018

This bill makes a series of changes relating to health insurance coverage, costs, and funding mechanisms. Among other things, the bill expands requirements relating to coverage of preexisting conditions to include short-term, limited-duration insurance and also establishes a national reinsurance program.

Actions Timeline

- **Mar 13, 2018:** Referred to the Subcommittee on Health.
- **Mar 9, 2018:** Referred to the Subcommittee on Health.
- **Mar 5, 2018:** Introduced in House
- **Mar 5, 2018:** Referred to the Committee on Energy and Commerce, and in addition to the Committees on Ways and Means, and Education and the Workforce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
